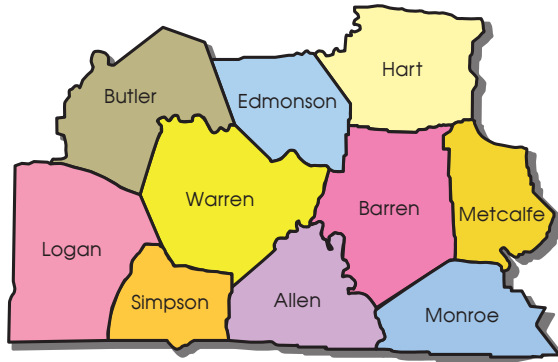


Scope of Services

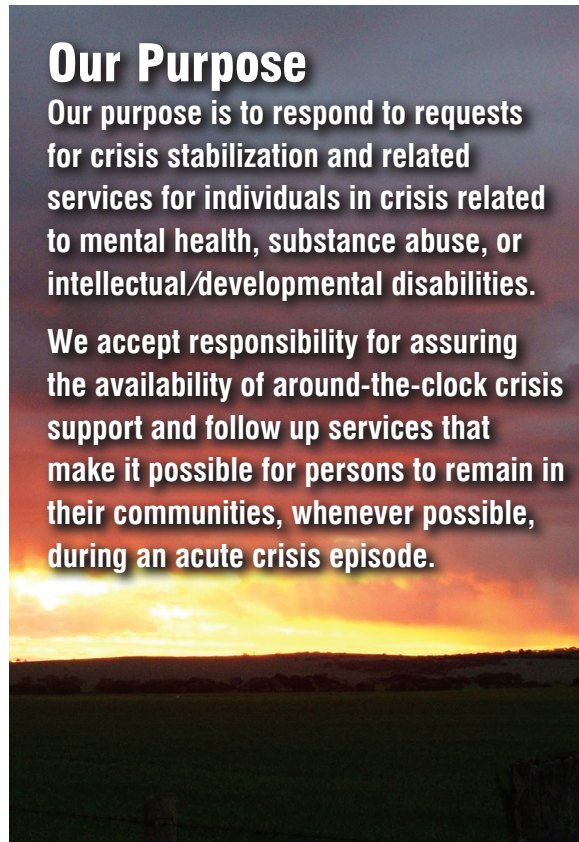
We serve adults 18 years of age or older in the 10-County BRADD Region who are in need of crisis stabilization.

Services Offered

Adult Crisis Stabilization Unit

Our Adult Crisis Stabilization Unit is an 8-bed facility designed to provide short-term residential crisis stabilization care to adults 18 years of age and older. Admission is voluntary and the unit is seclusion and restraint free.

The scope of services at the Adult Crisis Stabilization Unit is designed to provide 24 hour crisis care that includes the following:

- Assessment of the individual's needs and development of a plan of care with a licensed clinician
- Daily individual and group psychotherapy sessions
- Access to psychiatric services for medication evaluation, prescribing and monitoring
- Care Coordination to assist the individual with referral and scheduling of other needed services, including outpatient follow-up
- Crisis Safety Planning with a licensed clinician who will assist the individual in developing a crisis prevention plan to follow upon discharge

Mobile Crisis

24 hour Mobile Acute Crisis Service is available 24/7/365. Mobile Crisis offers an immediate response to individuals who may need support to prevent a crisis or are currently experiencing a crisis.

Mobile Crisis evaluations are voluntary, HIPPA compliant, and conducted in locations that are considered safe, such as police departments, hospital emergency rooms, personal care homes, schools or workplaces.

A licensed clinician will respond to a mobile crisis call and provide a thorough evaluation. The evaluation is based on models of mental status examination, clinical interview and any other assessment tools deemed necessary. After completing the evaluation, the clinician will provide recommendation for services and will assist in linking the individual to those services.

Mobile Crisis response is initiated by a phone call to LifeSkills HelpLine (270) 843-HELP (4357) from any agency or community partner in the LifeSkills ten-county region. Staff will gather basic identifying information by phone and dispatch an evaluator to the site as soon as possible.

Walk-In Services

Our Adult Crisis Stabilization Unit is open 24/7, and offers in-person crisis support, assessment, information and referrals. Anyone experiencing a crisis can walk in to our Crisis Stabilization Unit where they will receive a confidential assessment by a licensed clinician who will make recommendations for care based on the outcome of the assessment.

Crisis Support Line

Qualified staff are there 24/7 to answer the Helpline and provide immediate support and solutions and connect you to further resources, if needed.

Court Ordered Involuntary Hospitalization Services

In compliance with KRS 202A, LifeSkills' Crisis Services provides court ordered evaluations for involuntary hospitalization. LifeSkills' Crisis Services has a team of Qualified Mental Health Professionals who can perform these evaluations 24 hours per day.
